The aforementioned responsible party, _____, hereby understands and agrees to the following rules and/or the Leesville Leisure Pool rental policies:

- Cost for pool party is \$100** for parties up to 25 "swimmers" with exclusive use of four reserved tables w/umbrellas. There will be a charge of \$2.50 per additional swimmers (over first 25). **ALL guests must check-in at front and will be given a bracelet designating if they will be swimming or not.** initials _____
- A non-refundable deposit of \$50.00** is required at time of reservation. This deposit is forfeited if the responsible party cancels with less than 24-hour notice or is a "no-show" for the pool rental. The deposit will be used toward the final rental fee. initials _____
- Lifeguards will have ABSOLUTE AUTHORITY** over all safety issues concerning pool patrons. If a persistent problem occurs with a pool rental guest, the responsible party will be asked to request their guest to leave the pool area for the duration of the rental time. If the problem is not resolved, Pool Management will either request that the guest leave the pool facility, or if needed, will call the Leesville Police Department for assistance. initials _____
- No food or beverages in glass containers will be allowed.** Alcoholic beverages are strictly prohibited. Any food and beverages provided must be consumed at the designated table areas. Barbecue grills may not be brought into the pool area for any reason. initials _____
- All participating guests of the pool party are required to obey and respect the established and posted rules of the Leesville Leisure Pool.** initials _____
- It is the responsible party's obligation to assure that all guests leave the pool area promptly** at the end of the pool rental to allow for proper maintenance and closure of the facility. initials _____
- Parking** on the grass surrounding the pool area is strictly prohibited. All guests will be required to park in the parking lot adjacent and in front of the pool initials _____
- Rental fees must be paid in full** before anyone is allowed into the pool. initials _____
- In the event of inclement weather**, management will contact the responsible party prior to the time of the rental and either reschedule the event or submit a request for a refund. Inclement weather during the party will require the lifeguard team to follow appropriate weather-related safety protocol. There will be no refunds once a party has passed the first 30 minutes. initials _____
